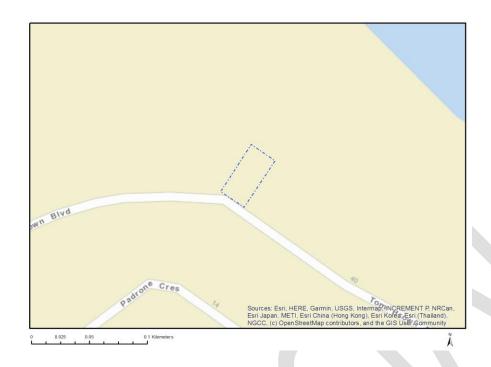

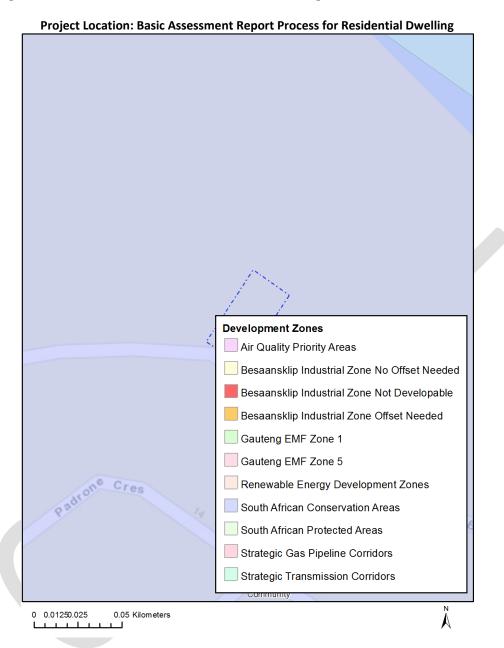

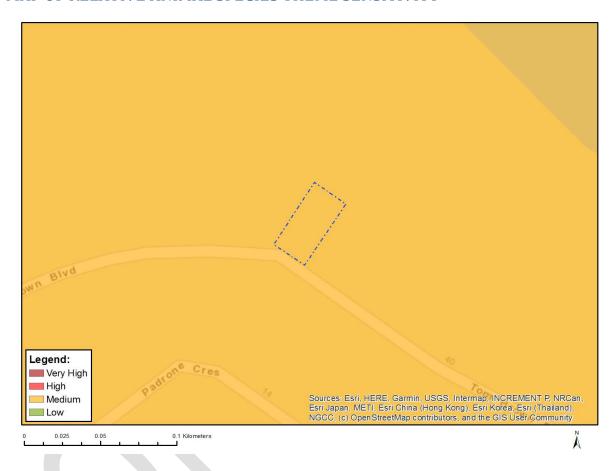

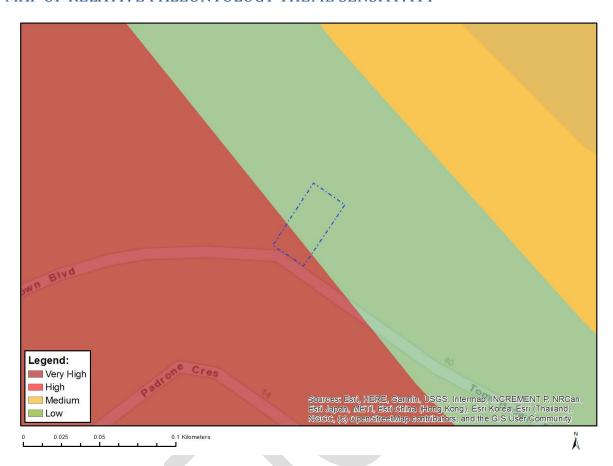
### MAP OF RELATIVE DEFENCE THEME SENSITIVITY

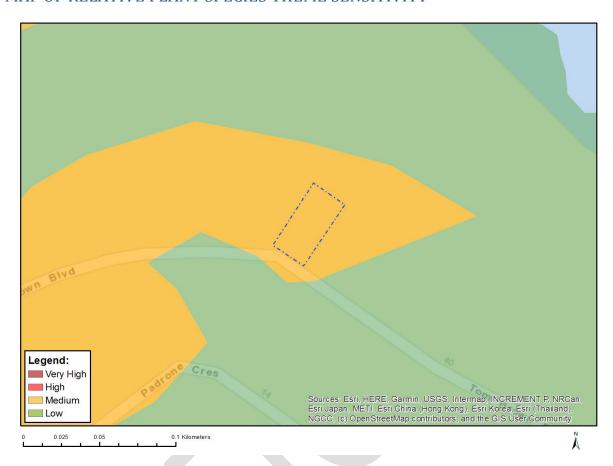
# MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY
