STANDARD CONDITIONS

1. The holder of this permit shall return it to the Chief Executive Officer: Western Cape Nature Conservation Board, Private Bag X29, Gatesville, 7766, within 14 days of the date of expiry thereof.
2. In addition to the above-mentioned condition, the holder of this permit must apply for the renewal of this permit (should they wish to renew it) AT LEAST three months prior to the expiry date of this permit. The onus is upon the holder of this permit to apply timeously for renewal.
3. The transport of live animals with this permit must be done in accordance with the provisions set out in SABS 0331 (Translocation of Certain Species of Wild Herbivore), SANS 10379: 2005 Edition 1 (South African National Standard: Zoo and aquarium practice), the Animals Protection Act, 1962 (Act 71 of 1962) and IATA specifications, where applicable.
4. This permit is subject to the approval from the Veterinary Services, where applicable.
5. THIS PERMIT IS SUBJECT TO THE SPECIAL CONDITIONS.

TAKE NOTE OF THE FOLLOWING:

1. This permit is valid for the period specified therein and must be returned within fourteen days of the date of expiry thereof to this office.
2. This permit does not authorise you to buy, sell, donate, receive as a donation and/or transport any protected wild animal. Permits for the fore-mentioned must be obtained from this office beforehand and applications must be addressed to this office, stating the number and species (scientific and common names should be mentioned) of the animals you wish to acquire, as well as the name and address of the person from whom you wish to obtain the animals.
3. Regulation 36 of the Nature Conservation Regulations, promulgated by Provincial Notice 955 dated 29 August 1975, provides that any person who keeps wild animals, except birds which are not endangered or protected wild animals, in captivity, shall keep a register in respect of such animals in which he shall -
 - 3.1. make a dated record in relation to -
 - 3.1.1 the name of each species, and
 - 3.1.2 the number of each sex of every species, or, if it is impossible to distinguish the sex, the total number of each species, which is so held, and
 - 3.1.3 as soon as any change occurs in respect of the species or number of each sex of every species or, if it is impossible to distinguish the sex, the total number of every species, keep a dated record in respect of -
 - 3.1.4 the name of the species in respect of which such change has occurred;
 - 3.1.5 the number of each sex of every species or, if it is impossible to distinguish the sex, the total number of every species in respect of which such change has occurred;
 - 3.1.6 the cause of the change, and
 - 3.1.7 if such change has occurred in consequence of the purchase, sale, donation or receipt as a donation of wild animals, the name and address of every person who is party to such purchase, sale, donation or receipt.
 4. Every record contemplated in paragraph 3.1 shall be retained for as long as the wild animal, in respect of which such record has been made, is kept in captivity and, at the termination of such captivity, for the period of two years immediately succeeding such termination.

SPECIAL CONDITIONS

1. This permit does not authorize any form of non-essential human/wildlife contact or direct physical interaction. CapeNature does not support, condone nor encourage such non-essential human/wildlife contact or interaction. CapeNature regards such activity as highly irresponsible, undesirable and potentially dangerous and urges the responsible person/permit holder to refrain therefrom at all times.
2. CapeNature will not be liable for any injuries or damage to any person or property in connection with non-essential human/wildlife contact or direct physical interaction.
3. The permit holder must be in possession of a license in terms of the Performing Animals Protection Act No. 24 of 1935 and the Performing Animals Protection Amendment Act, 2016 (Act No. 4 of 2016) before any animals are used for shows / exhibitions. This permit does not exempt the holder from obtaining a Performing Animal Protection Act License and Certificate before exhibiting wild animals.
4. No breeding is allowed. Male Lions to be kept at the facility must be permanently sterilized. Alternatively, a scheduled contraception program for female Lions approved by a veterinarian must be implemented and the detail of such program including the scheduled administration dates and intervals, must be supplied in writing to CapeNature. Proof of male Lion vasectomy must be supplied in writing to CapeNature. Proof of administration of contraception for female Lions must be supplied to CapeNature in writing after every administration.
5. This permit is valid for the Western Cape Province only.
6. CapeNature reserves the right to conduct inspections or investigations and to withhold or cancel any permits if the permit holder is found guilty of any contravention of the Ordinance or any irregularity.
7. A fence maintenance patrol schedule must be implemented, with fence patrols that must take place on a daily basis.
8. Fence maintenance logbooks must be kept up to date, including overall fence condition, vegetation encroachment, fire / flood damage, fence maintenance / repair, detail of voltage checks (which must be made available for inspection on request);
9. Each energiser must be supplied with a back-up power source;
10. The enclosure must be maintained to meet the minimum specifications for captive Lions as stipulated in the Fencing and Enclosure of Game and Predators in the Western Cape Province Policy, version 2, 2022 (as amended).
11. All enclosures must be adequately secured to prevent unauthorized entry.
12. A nature conservation officer may inspect the permit holder's enclosure at any time without previous notice.
13. No animal mentioned on this permit may come into contact with any free roaming wild animals.
14. The permit holder must inform CapeNature George office (tel: 087 087 3062) immediately in the event of any wild animals escaping and provide details in writing within 24 hours. The permit holder must immediately start a contingency plan and is fully responsible for the immediate recovery/capture of the animal and must inform CapeNature as soon as possible once the animal has been recovered/captured.
15. The permit holder must inform CapeNature George office (tel: 087 087 3062) immediately in the event of any wild animal deaths and provide details in writing within 24 hours. Photographic evidence of all animal deaths corresponding to captivity register must be kept on record for inspection by CapeNature. Animal carcasses must be kept until disposal is approved by CapeNature.
16. The necessary steps to reduce the risk of fire, operational ability to implement fire suppression and emergency evacuation procedures for staff, tourists and the Lions must be addressed on a continuous basis. CapeNature must be informed immediately before any emergency evacuation of Lions takes place and the necessary details of where the Lions will be temporarily kept be specified.
17. All carnivores that are kept in captivity or imported into the Western Cape Province must be permanently marked by the implantation of a microchip.
18. The animals must be managed according to approved management plan dated 28/08/2023, and associated management approval letter (reference 1/2/1/3/G74, dated 27/03/2024).
19. The animals will be administered vaccines, and other relevant medication, for relevant diseases, as required and advised by the veterinarian, with reference to management plan requirements, for the prevention of Feline Aids, Leukaemia Virus, Panleukopaemia Virus, Calici Virus and any other recommended by the vet. Proof of these vaccinations must be included on a vet report and such report emailed to CapeNature at wmeyer@capenature.co.za.
20. CapeNature requires that the permit holder to convey a conservation message in an educational program and amongst other things discourage the keeping of wild animals in captivity.

1. This permit is valid for the Western Cape Province only.
2. The permit is non-transferable, is valid for the permit holder only and only the permit holder may present shows.
3. The applicant must have a valid permit to keep animals in captivity, which he intends to use for show purposes.
4. Only the animals mentioned in the addendum to this permit may be transported for show purposes.
5. The Western Cape Nature Conservation Board will not be held responsible for any incident arising as a result of the exhibition of animals, especially venomous snakes, by the permit holder.
6. Adequate care must be taken to ensure the safety of the public during shows.
7. All cages must be adequately sealed to prevent them from being opened by the public, especially children.
8. Should any of the animals mentioned in the addendum to this permit die, then the holder of this permit shall record the particulars regarding the date, species, number and sex (if possible) of each of the species of such wild animals, that died and the carcasses of such dead animal must be preserved for inspection by the Western Cape Nature Conservation Board (should an inspection be deemed necessary by the Western Cape Nature Conservation Board).
9. No animals (including snakes) may be sold, donated or swapped, without the prior written approval from the Western Cape Nature Conservation Board.
10. The Western Cape Nature Conservation Board requests the permit holder to convey a conservation message in the educational program and the keeping of wild animals (especially reptiles) in captivity should not be encouraged.
11. The Western Cape Nature Conservation Board reserves the right to conduct inspections or investigations and to withhold or cancel any permits if the permit holder is found guilty of any contravention of the Ordinance or any irregularity.
12. Written permission must be acquired beforehand from the property owner(s) of the property on which shows are presented.
13. The immediate neighbours adjacent to the property where the wild animals (especially venomous snakes) are to be kept, must give their written permission for these potentially dangerous animals to be kept in captivity by the applicant.
14. The local authority must give written permission for the wild animals (especially venomous snakes) to be kept in a residential area.
15. A register must be kept at all times of the animals kept in temporary captivity at the show property. The register must be available for inspection at all times by any District Services Officer of the Western Cape Nature Conservation Board.
16. Separate registers must be kept for animals in temporary captivity and those in permanent captivity.
17. Problem animals that are kept in temporary captivity may not be used for show purposes.
18. The permit holder must be in possession of a licence in terms of the Performing Animals Protection Act No. 24 of 1935 and the Performing Animals Protection Amendment Act, 2016 (Act No.4 of 2016) before any animals are used for shows / exhibitions.
