



ANGLING CLUB PROPERTY BEACON AND BOUNDARY

PORTION 58 FARM HANGLIP 305

We refer to our recent discussions.

Attached hereto various diagrams and notes, to advise and explain our club's property boundaries.

BACKGROUND:

- 1. The Club-property originally comprises of Portion 42 Farm 305 Hanglip.
 - (See Annexure "A", diagram No SG 9914/1973 attached hereto)
- 2. A certain Portion "x", to be subdivided from portion 16 of the Fam Hanglip 305, was donated to the club by Peter Anderson Gregg. When he sold his property to "Twin Rivers" it included Portion "x" as per diagram attached, Annexure "A". When then instituted Legal action for the Court matter, we were successful with.
 - See Annexure "B" attached.
- 3. The said portion "x" was then subdivided and became Portion 57 Farm Hanglip 305. Attached as Annexure "C".



- 4. Portion 57 (above) was then transferred by us to the Club with condition to consolidate it with Portion 42, (Annexure A), an existing property at the time.
- 5. The two properties were consolidated and became our present property, Portion 58 Farm Hanglip 305.
 - See Annexed diagram SG 2335/93, representing the consolidated Farm. Annexure $D_1 + D_2$
- 6. The original Coastal boundary historically was the High-Water mark, but during 1993, an Agreement as to "Beacon and Boundaries" was enforced by the State, and the "Highwater-line" was surveyed according to its original line and fixed beacons were established.
- 7. This caused a fixed boundary line, along the Keurbooms river. See Annexure "E", attached hereto.
- 8. The dotted line running through Portion "x" as indicated split portion "x" into two parts. The area between the initial High-Water mark and the indicated present High-Water mark is in fact not our property, but State land.
- 9. This situation was then, November 2006 submitted to Adv PF Jooste of Port Elizabeth, a specialist on the subject.
- 10. In terms of the Coastal Legislation that lower part of Portion x on Annexure "E" came about years later after building of the bridge and the 1980's flood, which by law became State land.

It was then registered with the State Origin Department of Nature, to secure a lease agreement as with the jetty and the slipway.

This explains the status of that portion of portion "x" under discussion.






